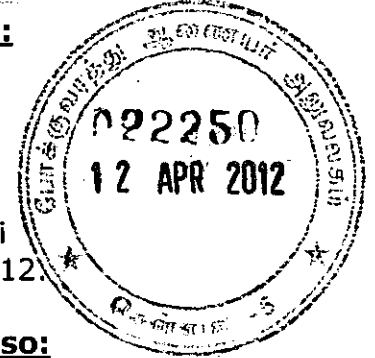

ORDER:

In the Government order first read above the Government have ordered restructure of the fee for allotment and release of advance numbers by the Registering Authority in respect of vehicles whose value is less than Rs.4 lakhs and for all imported cars and other vehicles whose value exceeded Rs.4 lakhs. In the Government Order second read above the Government have revised the fees to be collected for allotment of advance registration numbers by the Government.

2. The Transport Commissioner in his proposal third read above has now requested to revise the fee structure for allotment of registration numbers by the Registering Authority since the fee has been last revised ten years back. He has also requested the Government to revise the fee structure in respect of the advance registration numbers to be allotted by the Government since these numbers are fancy numbers and allotted in special cases only.

3. The Government have examined the request of Transport Commissioner and have decided to accept the same. Accordingly the Government in the Government order fourth read above issued notification to amend the Table under rule 132 of the Tamil Nadu Motor Vehicles Rules, 1989 for enhancement of fees to be collected for allotment of advance registration numbers by the Government and the Registering Authority inviting objections or suggestions from public on the proposed amendment to the said Tamil Nadu Motor Vehicles Rules, 1989 and the said draft amendment to the said rules has been published in the Home Department Notification No. SRO A-11(a) 2012, at pages 1 and 2 of Part III-Section 1(a) of the **Tamil Nadu Government Gazette Extraordinary**, dated the 31st March 2012.

4. No objections or suggestions have been received from any person. Therefore, the Government have decided to confirm the draft amendment to the Table under rule 132 of the Tamil Nadu Motor Vehicles Rules, 1989, published in the said **Tamil Nadu Government Gazette Extraordinary**, dated the 31st March 2012. Accordingly, the following Notification will be published in the **Tamil Nadu Government Gazette Extraordinary**.

NOTIFICATION.

In exercise of the powers conferred by sections 65 and 211 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Motor Vehicles Rules, 1989, the draft of the same having been previously published, as required by sub-section (1) of section 212 of the said Act.

AMENDMENT.

In the said Rules, in rule 132, in the Table, for the entries in columns (2), (3) and (4), against the Serial number 1 in, column (1), the following entries shall, respectively, be substituted, namely:-

	(iii) for vehicles whose value is less than Rs.4,00,000/- (Rupees four lakhs only)	Rs. 10,000/-	91 (3)
	(iv) for all imported cars and other vehicles whose value exceeds Rs.4,00,000/- (Rupees four lakhs only)	Rs. 16,000/-	91 (3)
