ORDER:-

The Hon'ble Minister for Transport while moving Demand No.25 relating to Motor Vehicles Acts - Administration on 08.09.2021 has made the following announcement on the floor of the Assembly:-

Pursuant to the above announcement, the Transport Commissioner has sent a proposal wherein he has stated that the following three Services can be availed contactless using Aadhaar as identity document which simplifies the Government delivery process, brings in transparency and efficiency and enables applicants to get their work done directly in a convenient seamless manner. This will reduce the crowd in Regional Transport Offices and help to facilitate citizens.

- i. Learner's Licence
- ii. Renewal of Driving Licence, and
- iii. Change of address in Driving Licence.

3. The Transport Commissioner has, therefore, requested the Government to issue necessary orders to permit him to implement the contactless services for obtaining Learner's Licence, Renewal of Driving Licence and Change of address in Driving Licence by using Aadhaar as identity document.

Accordingly, the Government hereby permit the Transport Commissioner to implement the contactless services for obtaining Learner's Licence, Renewal of Driving Licence and Change of address in Driving Licence by using Aadhaar as identity document.
