ORDER:

In the Government order first read above, the Government have issued notification inviting objection or suggestion on the amendment to be made to rule 6 of the Tamil Nadu Motor Vehicles (Regulation and Control of School Buses) Special Rules, 2012, framed in G.O.(Ms).No.727, Home (Tr.VII) Department, dated 30.09.2012. The same has been published in Home Department Notification No. SRO B-34/2022 at page 66 of Part III - Section 1(b) of the Tamil Nadu Government Gazette, dated the 29th June, 2022.

2. Few objections and suggestions have been received from the general public on the above draft amendment.

3. The Government after careful examination have decided to overrule the objections and suggestions and to confirm the said draft amendment issued in G.O.(Ms).No.292, Home (Tr.VII) Department, dated 15.06.2022. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by clause (xxxii) of sub-section (2) of section 96, section 111, and sub-section (2) of section 138 of

the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Motor Vehicles (Regulation and Control of School Buses) Special Rules, 2012, the draft of the same having been previously published, as required by sub-section (1) of section 212 of the said Act.

AMENDMENT.

In the said Rules, in rule 6, after sub-rule (16), the following sub-rule shall be added, namely:-

"(17) Fixing of cameras and sensor.- In every School Bus,-

- (a) A camera shall be fixed at the front end.
- (b) A camera shall be fixed at the rear end in such a manner that the driver while taking reverse can have a complete view of the rear side.
- (c) A sensor shall also be fixed at the rear end to give warning signal".
