### ORDER:-

The Hon'ble Minister for Transport, while moving the Demand for Grants relating to Motor Vehicles Acts – Administration (Demand No.25), has made the following Announcement for the year 2022-2023 on the floor of the Assembly on 05.05.2022.

- ஆ) போக்குவரத்து அல்லாத வாகன உரிமை மாற்றத்தினை இணையத்தில் சம்மந்தப்பட்ட அலுவலகத்திற்கு தெரிவித்தல்.
- இ) பதிவுச் சான்றில் தவணைக் கொள்முதல் விவரத்தினை மேற்குறிப்பு செய்தல்.

2. Pursuant to the above Announcement, the Transport Commissioner / Road Safety Commissioner has sent a proposal wherein

he has stated that the following three contactless Regional Transport Office services to the citizens by using Aadhaar as identity document which simplifies the Government delivery process, brings in transparency and efficiency and enables applicants to get their work done directly in a convenient seamless manner. This will reduce the crowd in Regional Transport Offices and help to facilitate citizens.

- (i) Surrender of class of vehicle from Driving Licence,
- (ii) Notice of transfer of ownership of non-transport vehicle and
- (iii) Endorsement of hire-purchase agreement

3. The Transport Commissioner / Road Safety Commissioner has therefore, requested the Government to issue necessary orders to permit him to implement the above three contactless services to the citizens by using Aadhaar as identity document.

4. The Government, after careful examination of the proposal of the Transport Commissioner / Road Safety Commissioner have decided to accept it. Accordingly, the Government hereby permit the Transport Commissioner / Road Safety Commissioner to implement the following three contactless Regional Transport Office services to the citizens by using Aadhaar as identity documents.

- (i) Surrender of class of vehicle from Driving Licence,
- (ii) Notice of transfer of ownership of non-transport vehicle and
- (iii) Endorsement of hire-purchase agreement

5. The Transport Commissioner / Road Safety Commissioner is requested to send a fully implemented report to Government.
